

PARTNERSHIP IN EXCELLENCE

Part of an ongoing collaboration between Saint Francis Hospital and Medical Center/Mount Sinai Rehabilitation Hospital and the University of Saint Joseph

Saint Francis Hospital and Mount Sinai Rehabilitation Hospital are working with the University of Saint Joseph to offer educational opportunities for all SFH/MSRH staff. Our Partnership in Excellence program provides a 20% reduction in USJ tuition for employees of SFH/MSRH.

- The University of Saint Joseph will waive application fees for undergraduate or graduate admission to SFH/MSRH employees.
- Through the Partnership in Excellence Program, eligible SFH/MSRF employees will receive a 20% discount in tuition at USJ. The discount does not apply to full-time USJ students receiving financial aid, or to students enrolled in the Pharmacy or Physician Assistant Studies programs.
- USJ supports students with academic advising, financial aid, counseling, and guidance.
- SFH/MSRH employees enrolled in courses have access to all campus amenities offered at the University, including the O'Connell Athletic Center, the Center for Academic Excellence, and the Pope Pius XII Library.
- This eligibility form must be completed, signed by appropriate administrators, and submitted each semester that a SFH/MSRH employee registers for a class. The signed form must be presented by the student to the University of Saint Joseph at the time of registration to be eligible for tuition reduction. Students identifying themselves as SFH/MSRH employees after registration will be ineligible for the tuition benefit that semester.

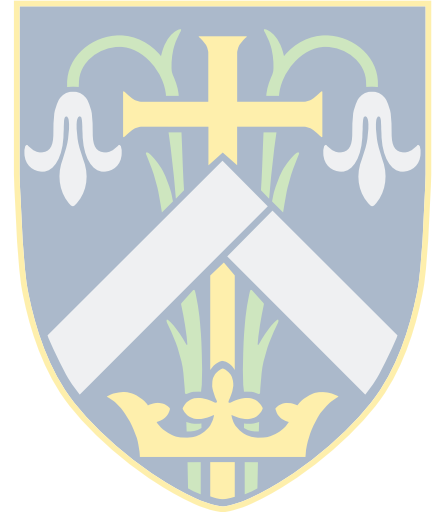
